Our Founder: Billy Casper

With a career spanning more than 50 years as a golf professional, Billy Casper has become a legend among golfers. The highlights of his career include 51 PGA Tour victories, including the 1959 and 1966 U.S. Opens and the 1970 Masters Championship.

Billy holds the PGA's 7th best all-time victory record, is a member of the PGA World Golf Hall of Fame, and was awarded five Vardon Trophies. He played on eight U.S. Ryder Cup Teams, was U.S. Ryder Cup Captain in 1979, and remains the winner of the most U.S. Team points in Ryder Cup history.

In 2001, Billy was honored by the Royal Family of Morocco for his contributions to the game of golf. As recipient of the Classe Exceptionnelle du Wissam Riada, he is the only American to receive such a commendation. In 2010, Billy received the PGA's Distinguished Service Award given annually to an individual who displays leadership and humanitarian qualities, including integrity, sportsmanship and enthusiasm for the game of golf.

Billy's family and friends host this one-of-a-kind event to honor his love for his fellow man and desire to give back.
